### ***Declaration by Applicant***

In the event that either of us is not a member, he/she has to : a) obtain a transfer letter and FCBC's letter of acceptance into our membership roll or b) a written permission from his/her pastor before we can be enrolled in the Marriage Preparation Course (MPC).

2. I need to attend ALL classes and complete ALL homework assignments.

3. We SHOULD NOT set a wedding date until we have met with the Marrying Pastor after attending all lessons and completing all homework assignments. The wedding date must be at least six months after the MPC ends.

4. It is our responsibility to file notice of our wedding at least 21 days before our actual wedding date with the Registry of Marriages.

5. It is our responsibility to make arrangements and secure a church for our wedding.

6. I will serve in FCBC's Gkidz David Club for 10 consecutive weeks during or after the MPC.

7. After our wedding, we will forward our new permanent address to the church's Wedding Services for updating purposes.

I fully understand that to be married in this Church, the above conditions need to be adhered to. I declare that the information given is true, correct and complete.

# Approval For Remarriage Form

If you are a widower/widow seeking remarriage, this form is not necessary for you.
